A Iwi Hapū Management Plan (**IHMP**) is a document developed and approved by iwi/hapū that describes resource management issues of importance to them as tangata whenua. IHMP may also contain information relating to specific cultural values, historical accounts, descriptions of areas of interest (iwi/hapū rohe) and consultation/engagement protocols for resource consents and/or plan changes.
